#### Regulatory compliance

#### A defensible record

#### **Controls framework**

Import and aggregate controls with capabilities to identify duplicate, ineffective, and conflicting controls. Link controls to authority documents, assets, risks, and more.

#### **Change management**

Ensure regulatory changes are standardized, communicated, and accessible. Use workflow to manage the impact from regulatory changes.

#### **Violations and incidents**

Investigate, document, and manage violations and incidents. Link to policies, controls, and risks, then use workflow for updates and escalation.



## Managing compliance and policies with Lockpath

Lockpath helps companies comply with multiple regulations while reducing costs associated with compliance activities. Lockpath users store authority documents (i.e., regulatory requirements, compliance mandates, customer contracts) in a central database and links these documents to associated controls, policies, procedures, assets, risks or even third parties. This simplifies gathering evidence of compliance or performing a gap analysis to determine what needs addressing.

The same principle also applies to policy management. Within Lockpath, policies, procedures, and authoritative sources can serve as a single source of truth. Import policies or create new ones, and then use Lockpath's workflow engine to automatically initiate and track the policy review process.

When it's time to publish a policy, simply alert employees by issuing awareness notifications in Lockpath. You can also set up automatic policy reminders, capture attestations for reporting purposes, even test employees on their policy comprehension.
