## **Challenge: Managing Policies with Binders Makes HIPAA Compliance Difficult**

When the employees of Sumner Mental Health Center (SMHC) needed to find a policy they had to go from desk to desk looking for the binder that held it. When the binder was found, it was often difficult to determine if the policy was up to date and accurate. It also took management significant time to find, review, and approve new policy documents. "We were forever having the notebooks get misplaced," said David Robinson, Director of IT. "They wouldn't be in an office when somebody would come so we would have to try to find it."

SMHC needed to move HIPAA policies from binders and desk tops to an electronic management system that allowed access to all employees, barred outdated policies from being used and prevented current policies from getting lost while continuing to comply with HIPAA requirements.
