## The Challenge

Collecting conflicts of interest (COI) related to gifts and entertainment can be an overwhelming task during the holidays. While most organizations often complete an annual campaign to collect potential conflicts of interest, these campaigns most often occur towards the beginning of the year or at the start of the fiscal year. ### Process: A Simplified COI Process

- 1 Administrators create on-demand disclosures and make available for employees to access through COI Disclosures on NAVEX One to disclose any gifts on an ad hoc basis.
- 2 When gifts are received, employees access the on-demand disclosure form and complete the questionnaire that automatically flags potential conflicts.
- 3 Flagged conflicts will create a notification for the COI Disclosures administrators to review, and tracking can begin.
- 4 Administrators can view detailed reporting to visualize the performance of on-demand disclosures and any potential COIs uncovered to ensure all potential risks have been addressed.
